



## DEHYDRATED COOKED CHICKEN TYPE M-5 AR

### General description

This product is produced by air drying cooked chicken meat in an approved factory (according to EC regulations 852/2004 and 853/2004).

### Ingredients

Cooked chicken meat (75%), salt (15%), chicken broth (9,9%) and antioxidant: extract of rosemary (0,1%).

### Physical standards

Appearance	Granules with $\pm$ 5 mm diameter and variable length.
